Subject: Grant of a Special Increment to the Police Personnel.

Sir,

I am directed to invite a reference to the subject cited above and to say that the Governor of Punjab is pleased to decide that all the Inspectors, Sub-Inspectors, Assistant Sub-Inspectors, Head Constables and Constables in the regular service of the State Government shall be entitled to an additional increment with effect from 1st December, 2011 subject to the following conditions:-

- (a) The additional increment admissible under these orders shall be calculated in accordance with rule 9 of the Punjab Civil Services (Revised Pay) Rules, 2009.
- (b) The amount of additional increment shall be treated as pay for all intents and purposes.
- (c) The date of next annual increment of the employee shall not be changed.
- (d) The additional increment under these orders shall be admissible only to those police personnel who did not commit an act of indiscipline by way of participation in any strike etc.
- (e) The additional increment under these orders shall be admissible only to those employees, who are in regular Government service before 1st December, 2011. In other words, the employees who join Government service on or after the first day of December, 2011, shall not be entitled to the benefit of additional increment admissible under these orders.
