**TERMS AND CONDITIONS OF AUCTION OF CONDEMNED VEHICLES NOS.  
CH01-G-0066 & CHOI-G-0979 LYING AT THE PREMISES OF CHANDIGARH SPORTS  
COUNCIL, SPORTS COMPLEX, HOCKEY STADIUM, SECTOR – 42, CHANDIGARH**

**1. EARNEST MONEY DEPOSIT**

The bidder shall deposit along with bid form earnest money of Rs.10,000/- each vehicle in the shape of Banker's cheque/demand draft in favour of the Secretary, Chandigarh Sports Council, Chandigarh

**2. SEALED COVER:**

The bids offering rates for the purchase of each of the vehicles should be addressed to the Secretary, Chandigarh Sports Council, Chandigarh, SPORTS COMPLEX, HOCKEY STADIUM, SECTOR 42, CHANDIGARH – 160036 and be put in sealed cover enclosed with the following superscription "Tender for the purchase of condemned vehicles Registration No. White Color Maruti Esteem Car MPI VXBS III/ 2006/ (CH01-G-0066) and Swaraz Mazda (mini bus) 32 seater/1998/CHOI-G-0979. The envelope should also bear the name, address and seal (if available) of the bidder.

**3. BID FORM:**

Bid amount should be quoted only in the prescribed tender schedule enclosed (Annexure – 'A'). Bid amount quoted in any other form will be rejected. **FOR EACH VEHICLE SEPARATE BID FORM SHOULD BE USED.**

**4. INSPECTION:**

The vehicles to be auctioned is available for inspection by the bidder at the specified location during the office hours. Bidder should inspect the vehicles at the site and get satisfied of the conditions and quality of the vehicle (s) to be purchased before offering the bid amount.

## **5. BID OPENING:**

Bid will be received only upto the date and time prescribed Auction Notice. All the tenders received will be opened at 04.00 p.m. on 16.09.2017 by the Committee in the office of the Secretary, Chandigarh Sports Council, Chandigarh in the presence of the bidders or their authorized representatives, who choose to be present. Only participating bidders or their representatives will be permitted inside the premises. If the day of opening of the bids happens to be a holiday by any of the reasons, the bids will be opened on the next working day at 04.00 p.m.

## **6. ACCEPTANCE:**

**(A)** The bidder should quote the rate for purchase of the vehicles both in words and figures. If there is any difference in the figures and that in the words, the rate quoted in words will only be taken into account.

**(B)** The reserved price of the motor vehicle is fixed as under:-

- i) Esteem Car Rs. 50,000/- (Rupees Fifty thousand only).
- ii) Swaraz Mazda Mini Bus Rs. 80,000/- (Rupees Eighty thousand only)

**(Price quoted by the bidder should not be less than the reserved priced fixed for the vehicle).**

**(C)** If the highest bidder does not accept the offer of sale of vehicle for any reason whatsoever it may be, and withdraws from the bidding, the earnest money deposited by the bidder shall be forfeited. No conditional offer shall be entertained.

## **7. Goods and Service Tax :**

Appropriate Goods and Service Tax as applicable, if any, will be collected over and above the sale price in accordance with the Central Government Act / Rules in force. As such, the bidder should quote the rate exclusive of taxes while offering the rate in the bid form.

**8. Payment:**

**(A)** In the event of acceptance of bid, the successful bidder will be required to deposit full amount in the shape of Demand Draft in favor of Secretary, Chandigarh Sports Council, Chandigarh within 03 days from the issue of order, failing which the sale order shall be cancelled, earnest money deposit shall be forfeited and no further correspondence will be made on this issue.

**(B)** The condemned vehicle will be release for delivery to the successful bidder only after the full payment of the entire bid amount including deposit of Goods and service tax as applicable, if any.

**9. Delivery:**

**(A)** After complete payment, and on receipt of delivery authorization from the Secretary, Chandigarh Sports Council, Chandigarh, the successful bidder should remove the condemned vehicle at his own risk and his own cost within 24 Hours from the time of payment of the entire bid amount with due Goods and Service tax, failing which, a ground rent of 1% of the bid amount will be collected extra, for each day.

**(B)** Before taking the delivery of condemned vehicle, the bidder is required to produce any of documentary evidence for proof of their address.

**(C)** The address given in the bid form shall be deemed to be bidders address and correspondence sent on that address shall be considered to have been delivered to the bidder.

**(D) The Successful bidder will be responsible for getting the registration certificate of the vehicle transferred in his name at his own cost expeditiously and will be responsible for any misuse / theft / accident related to the vehicle, if used prior to transfer of registration. This office will not be responsible for any lapse on his part in this regard.**

**(E) The Successful bidder will also be deposit tax collected at source @ 1% of the total bid amount.**

**10. Loss or Damage:**

Once the bid is finalized and the entire bid amount collected, and delivery authorization issued, this office will not be responsible either for safe custody or for any loss or damage of the vehicle beyond 24 hours of finalization of bid.

**11. Other Conditions:**

**(A)** The highest bidder is responsible for all acts done either by himself or by his authorized representatives.

**(B)** In case of any dispute, it should be clearly understood that the decision of the bid opening Committee shall be final.

**(C)** The Secretary, Chandigarh Sports Council, Chandigarh reserves all rights to accept or reject any bid with or without assigning any reason thereof and the decision of the Secretary, Chandigarh Sports Council, Chandigarh will be final and binding on all.

**(D)** The highest bid once accepted is not transferable to anyone.

**(E)** All the bidders are deemed to have read and accepted the terms and conditions herein mentioned.
