**Terms and conditions:-**

1. The Director Cultural Affairs reserves all rights to modify terms and conditions as deemed fit in public interest or cancel Auction Process without assigning any reason(s).
2. The rates shall be firm and no price variation shall be allowed once quoted.
3. In case of any dispute, decision of the Director Cultural Affairs will be final.
4. In case of any failure in the parking service the contractor will be discarded for future assignments and whole bid amount deposited by the contractor will be forfeited.
5. Only those should give their offers, who have sufficient experience of such state level function and ensure.
6. Before participating in the Auction, the Bidder will have to deposit the Earnest Money of Rs.50,000/- (Rupees Fifty thousand only) in the shape of a Bank Draft drawn in favour of the Director Cultural Affairs, Chandigarh Administration in the Department of Cultural Affairs, U.T. Secretariat, Ground Floor, Sector 9, Chandigarh.

7. The contractor shall make all the necessary arrangements such as barricading to control the vehicles, entry and exit sign boards, marking of the car/scooter lanes etc. at the parking place for the convenience of general public.
8. The Contractor shall display through flex boards at various places displaying the parking rates of four wheelers and two wheelers for the knowledge of General Public.
9. The timing of the parking shall be from 10.00 A.M. to 10.00 PM. The Contractor will ensure that parking attendants are available for watch and ward of vehicles.
10. The Contractor shall deploy sufficient manpower in each paid parking to avoid inconvenience to the general public.
11. The Contractor while issuing the parking slip shall mention the parking time on the parking slip.
12. The Contractor shall be responsible for damage and theft(s) of vehicle(s) from parking areas during the parking hours.
13. The Department of Cultural Affairs shall not be responsible for any theft/damage to the vehicle before, during and after parking hours, even though the parking token was issued.
14. The Contractor shall declare his/her postal as well as permanent address and submit residential proof e.g. copy of ration card/electricity bill, voter identity card etc. alongwith copy of Aadhaar Card.
15. The Director Cultural Affairs, Chandigarh Administration has the right to cancel the parking contract without assigning any notice in case the contractor is found over-charging from general public and the bid amount deposited by the contractor will be forfeited.
