3. If the successful tenderer fails to lift the material within the stipulated period, his security deposit shall be forfeited.
4. The Tenders will be received upto 11:00 A.M on 15.9.2017 and will be opened at 3.00 P.M on the same day in the presence of Tender(s) or their representative(s) who may wish to be present. The parties are free to inspect the material on any working day.

TERMS AND CONDITIONS

1. The Tenderer shall quote rate per kg. On their letter head pad. The highest rate per kg. for Mixed White Waste Paper Cutting Consisting of Kraft Paper, Office Waste Record, packing Paper and all other type of waste paper material etc shall be considered as the highest Bid.
2. The successful Tenderer will have to lift the material on alternate days throughout the year as prescribed in the Tender form the date of issuance of acceptance letter through his own means of transportation.
3. Labour for Loading /Unloading of waste material shall be arranged by the bidder at his own cost.
4. Arrangement for packing of waste material shall have to be made by the bidder at his own cost.
5. The weighment shall be done at the weighing machine of the department.
6. If the department consider necessary weighment can also done at CITCO "Dharam Kanta". Weighing of unload truck and then the loaded truck, and the charges shall be borne by the purchaser.
7. The delivery of the waste material shall be made on actual weighment basis against full payment.
8. The successful bidder has to deposit Rs. 1,50,000/- (Rs. One lac fifty thousand only) as the performance security deposit in the form of fixed deposit receipt , Bank Guarantee from any Scheduled Bank payable at Chandigarh in favour of Controller, Printing and Stationery Department, U.T., Chandigatrh within 7 days from the issuance of acceptance letter. The validity of the performance security shall not be less than 14 months.
9. The earnest money of the successful bidder will be released after the receipt of performance security deposit.
10. The earnest money of the unsuccessful bidder will be released after finalization tender.
11. The successful bidder shall have to submit the proof of deposit of GST with this office.
12. All the waste material mentioned in the Tender shall be lifted by the bidder without sorting.
13. Conditional Tenders are liable to be rejected straight way.

14. All disputes will be subject to Chandigarh Jurisdiction.
